

Teague I.S.D. Board of Trustees Meeting Summary

The Board of Trustees of the Teague Independent School District met in Regular Session in the TISD Central Administration Office on March 24, 2011 beginning at 5:20 p.m.

Board Members present were: Jeff Gonzales (President), Debra Lawrence (Vice President), Lovie Whyte (Secretary), Randy Bruce (Member) and Stan Waldrip (Member). Members absent- Brian Bowers and Sushma Walker. Administrative staff members present were: Ned Burns, Bryan Clemmons, Mary Clary-Smith, Vickey Little, Darrell Evans, Carol Ann Dawley and Donnie Osborn.

The meeting was called to order and a quorum was established.

The meeting minutes for February 24, 2011 were approved as presented.

Current bills in the amount of \$2,302,885.22 were approved as presented.

The following reports were presented to the Trustees: a) Tax Collector's Report; b) Monthly Financial report; c) Instructional Report; and d) Enrollment Report.

Motion to approve the contract renewal with East Texas Insurance Associates for Student/Athletic Insurance was approved as presented.

Student meal prices for the 2011-12 school year were approved as presented. High School/Junior High = \$1.75; Intermediate School = \$1.50; Elementary School = \$1.25; and Breakfast (all campuses) = \$1.00.

Contract renewal for the 2011-12 school year with Interquest Detection Canines of Waco was approved as presented.

The following items were presented for information and discussion: a) revised draft School Facilities Use form; b) continued 2011-12 budget discussion; and c) proposed Huntsville Memorial Hospital – Sports Medicine.

Superintendent updated the current status of the S&P Construction punch list for the new secondary school. Mr. Clemmons updated the progress of the construction/installation of the new synthetic turf football field & track, stadium renovation and field house.

With regard to the acquisition of civil engineering services for the new roadways, drives and parking facilities, the following motion was approved: a) Goodwin-Lasiter, Inc and Huffman Consulting Engineers were designated as qualified; b) the Superintendent is authorized to first contact Goodwin-Lasiter Inc. to negotiate a satisfactory contract; c) in the event the Superintendent is unable to negotiate a satisfactory contract with Goodwin-Lasiter, Inc., the Superintendent is authorized to negotiate for a satisfactory contract with Huffman Consulting Engineers; and d) in the event the Superintendent is unable to negotiate a satisfactory contract with Huffman Consulting Engineers this process will end and another process for selection of a civil engineering firm may be initiated.

In accordance with Section 2.053(a) of the Texas Election Code, the Board of Trustees approved a motion to cancel the election scheduled to be held on May 14, 2011. The following candidates have been certified as unopposed and are hereby elected as follows: Lovie Whyte – Place 1; and Stan Waldrip – Place 3.

The Trustees approved the 2011-12 teacher contract revisions as recommended by the Superintendent.

Motion to approve the employment resignation (at the end of the 2010-11 school year) from Sarah English was approved.
