

Teague I.S.D. Board of Trustees Regular Meeting Summary

The Board of Trustees of the Teague Independent School District met in Regular Session in the TISD Central Administration Office on March 27, 2008 beginning at 5:17 p.m.

Board Members present were: Jeff Gonzales (President), Lovie Whyte (Secretary), Randy Bruce (Member), J.D. Hancock (Member), Debra Lawrence (Member) and Stan Waldrip (Member). Members absent: Scott Hamilton. Administrative staff members present were: Ned Burns, Jerry Burger, Darrell Evans, Vickey Little, Carol Ann Dawley and Chris Skinner.

The meeting was called to order and a quorum was established. Mrs. Vicki Brown presented recommendations for improving teacher salaries and the local leave policy.

The meeting minutes for February 28, 2008 were approved as presented.

Current bills in the amount of \$1,582,744.63 were approved as presented.

Motion to reject all bids for the sale of used school buses was approved.

The following motion was approved:

- a) effective with the 2008-09 school year, the Teague High School will schedule 8 instructional class periods per regular student day;
- b) the district requires no additional credits for graduation under the Advanced/Distinguished Achievement Program beyond those mandated by the State; and
- c) effective with the implementation of the 8 period instructional day in 2008-09, THS students will be required to take the following number of minimum credits per school year:

Ninth Grade Year & Tenth Grade Year – All students shall be assigned 8 instructional class periods per day.

Eleventh Grade Year & Twelfth Grade Year –

1) provided the individual student successfully passed all portions of the TAKS test during the previous school year and is on track to complete the required specific credits to graduate, the student will only be required to take not less than 5 instructional class periods per day.

2) specific students who did not successfully pass all portions of the TAKS test the previous year will be required to take additional study skills/TAKS preparation class periods per day (as determined by the principal or designee)

Motion to revise TISD policy FN (Local) and FO (Local) was approved as presented. Effective with the 2008-09 school year, the distribution of campus handbooks and the Student Code of Conduct will be internet-based with the provision that a paper copy of the campus handbook and/or Student Code of Conduct will be provided upon written request.

A brief update on the Secondary School Complex and Intermediate School planning was presented.

The following reports were presented:

- d) Enrollment Report.

The resignation of Linda Morris (Intermediate School Teacher) was accepted.
